 - Enroll in mobile banking: Download the mobile app and link to your online banking account.
 - Qualifying mobile banking transactions must occur within the FI's mobile banking app and linked to the user's online banking account.
- (Digital Card Management) CardHub
 - Set up a control with Cards.

Details on Qualifying Transactions:

The Sponsor services and the financial services generally offered at the various financial institutions vary. All Qualifying Transactions must be completed during the Sweepstakes Period. All entrants must be the primary accountholder of the FI account associated with the action used to enter.
